This matter being heard duly and regularly pursuant to the provisions of Section 123-134, Oregon Compiled Laws Annotated, upon the petition herein (verified April 7, 1947) and the Court finding that notice of the hearing on said petition was duly published as required by law, and that due proof of such publication has been made herein, and that no objections to the granting of the prayer of said petition have been filed and that the time prescribed by law for filing such objections has expired, and that no extension thereof has been granted, and the Court having examined under cath one of the petitioners and having received and considered evidence offered on behalf of the petitioners, and further finding from the proof submitted that the averments of the petition are true and that pursuant to the existing plan for reclamation of said drainage district the Board of Supervisors thereof has constructed and put into operation various projects as integral; parts of a comprehensive system of interior drainage and thereby reclaimed 2517 acres of land, more or less, within said District's territorial limits. and that said District's present plan for reclamation contemplates a system of interior drainage functioning solely by gravity and that a large part of the contemplated system has been completed but that it cannot and will not provide (for the beds of Little Sturgeon Lake and of Mouse Island Lake and for a few other areas) by gravity alone drainage to a sufficient extent to reclaim the same and to permit their use for the growing of crops until it shall have been supplemented by the installation and operation by said District at suitable points of auxiliary pumps, and that the installation and

operation of such auxiliary pumps would be feasible, would subject the land served thereby to maximum assessment by said district, would inure to the advantage of said district and to the landowners therein, would serve one of the principal purposes for which the district was organized could be accomplished at a cost less than the benefits to be derived therefrom, and would be in the public interest, and that it is reasonable, necessary and in the public interest that the relief sought by said petition be granted by this Court, good cause appearing therefor, it is

CONSIDERED, ORDERED, ADJUDGED AND DECREED that the prayer of said patition be and the same is hereby granted, and that permission be and it is hereby granted to the Board of Supervisors of Sauvie Island Drainage District and to change the plan for reclamation of said District by adding thereto a paragraph reclamation as follows:

FOURTH: Installation and operation of auxiliary pumps (to supplement the gravity system of interior drainage contemplated by paragraph Third of the present plan for reclamation) in areas where reasonably adequate drainage cannot be provided otherwise.
